- Personal information (e.g. name, address, date of birth)
 Characteristics (e.g. ethnicity, gender)
- Past and present job roles
- Health information














- Human Resources (HR)
- From you via paper health/electronic questionaries
- In the course of providing clinical services (e.g. vaccination history, blood test results, Lung function test, OPD reports

⊘ Why it is collected

- For the purposes of preventive or occupational medicine, for the assessment of the working capacity of the employee
- To ensure the health and safety of employees at work and to allow consideration of any adjustments that may be required to support their ability to work
- Data may also be used for research, audit or statistics but will be anonymised if this is the case

How long your data will be held for

Information will be held for 5-30 years after leaving employment as recommended by the organization unless there is a recognised clinical need or statutory requirement to retain it for longer.



How your data will be stored

- Most records are kept digitally on secure servers, which are hosted by the providers of our occupational health software systems and are password protected.
- They are accessible only to Occupational Health.



Who your information will be shared with

- Information about you will not be shared with third parties without your consent unless the law allows this, or there is a serious risk to life.
- Results of health surveillance will be passed on to the Health and Safety Executive (HSE).










